The cured sealants are in compliance with the rules of the

Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Official Journal of the European Union L 338/4 of 13.11.2004, lastly modified by article 5 of the Regulation (EU) 2019/1381 of 20 June 2019, Official Journal of the European Union L 231/1 of 6 September 2019, article 3, 1. (a) and (b),

as well as of the

Lebensmittel-, Bedarfsgegenstände- und Futtermittelgesetzbuches (Lebensmittel- und Futtermittelgesetzbuch - LFGB) in the version of the notification of 15 September 2021 (BGBl. I. p. 4253; 2022 I p.28), last amended by article 2 paragraph 6 of the act of 20 December 2022 (BGBl. I p. 2752), §§ 30 and 31),

and of the

Code of Federal Regulations, Food and Drugs (FDA), 21 CFR Ch. I (March 29, 2022 edition), § 177.2600.

Thus, the silicone sealants **Jackit Seal FDA** and **Jackit Seal** according to the sample material submitted may be used safely in the foodstuffs-related sector, for example for the grouting of wall and floor areas in companies which are preparing and processing foodstuffs. However, a direct contact with food is not intended.

This certificate of compliance has a validity of 2 years and consists of 3 pages. It was subsequently modified on 13 June 2025.
